About the Role

DPV Health offers a whole of life mental health service that is co-led by consumers and carers, embraces all levels of evidence to support each individual's recovery.

The Senior Mental Health Clinician will work as part of a team which provides triage, comprehensive mental health assessment, risk assessment and management, psychological intervention, and evidence-based therapy to people within a community-based care setting.

The clinician coordinates the clinical delivery of treatment and care, making sure people and their families receive timely, responsive, and suitable services to meet their needs. This role ensures that the service performs as a best practice example, and that the care delivered to people is of the highest possible standard.

Senior clinicians work autonomously providing a range of services including but not limited to secondary consultations, professional development, clinical supervision, assessment and systemic treatment, the consultant psychiatrist is available for second opinions and support.

Purpose and Scope of the position:

- Substantial clinical experience in a range of clinical mental health settings with highly developed mental health assessment skills.
- Demonstrated experience in the provision of mental health and risk assessments, capacity to formulate, make differential or provisional diagnoses, and provide brief solution focussed therapies.
- Demonstrated experience in suicide prevention or capacity to gain the experience swiftly.
- Knowledge and application of the biopsychosocial framework.
- Knowledge of and ability to deliver therapeutic modalities including but not limited to single session work, motivational interviewing, cognitive behaviour therapy, Acceptance Commitment Therapy, Interpersonal Therapy, Dialectical Behaviour Therapy, Schema, Mindfulness Cognitive Therapy, etc.
- Ability to deliver DBT (Dialectical Behaviour Therapy) skills group highly desirable.
- Strong capability in delivering Cognitive Analytical Therapy highly desirable.

Roles Key Accountabilities

Service Delivery

- Undertakes psychiatric assessments of makes diagnoses and works with the consumer and their family to develop a recovery plan.
- Uses evidence-based instruments that are tailored for the situation the consumer is facing.
- Provides ongoing treatment or makes recommendations for such in consultation with consultant.
- Deliver therapeutic interventions that are evidenced based, delivered individually, as a couple or group.
- Provides psychoeducation individually, group or community.
- Embrace evidence, caring, 'can do' and partnership as a basic tenet underpinning the philosophy.
- Negotiate multiple complex systems of care to the benefit of service users and their families.
- Ensure that treatment and care is delivered in a manner, which is sensitive to language, family needs, cultural gender, and individual differences and within the regulatory framework applicable to clinical mental health services.
- Provide user-friendly, accurate, relevant information to service users, carers, and families.
- Participate in the review of therapeutic goals, treatment, and care within the clinical review setting.
- Contribute to the ongoing development and maintenance of a therapeutic environment and a collaborative team atmosphere.

Management/Supervision:

- Identify professional development goals & pursue opportunities for learning.
- Participate in assisting with clinical fieldwork placements to students and participate in the education and training of students of other disciplines.
- Participate in and contribute to ongoing professional development activities and in-service training.
- Provide orientation to students & new staff of all disciplines.
- Provide supervision to junior clinicians.
- Provides and participates in professional development specifically training to DPV staff on evidenced base practice modalities.

Culture, Engagement, Diversity - People Experience

- Demonstrates behaviours aligned with DPV Health Values and Code of Conduct.
- Participate in regular supervision, annual work plans and annual performance reviews.

Qualifications, knowledge, skills and experience

- Clinical Psychologists: Registration under the Australian Health Practitioner Regulation National Law Act (2009) with the Psychology Board of Australia. General registration with a clinical psychology practice endorsement.
- Occupational Therapists: Registration under the Australian Health Practitioner Regulation National Law Act (2009) with the Occupational Therapy Board of Australia. An approved Degree from a recognised school of Occupational Therapy or other qualifications approved for eligibility for membership of the Australian Association of Occupational Therapy (Vic.).
- Registered Psychiatric Nurses: Registration as a registered nurse under the Australian Health Practitioner Regulation National Law Act (2009) with the Nursing and Midwifery Board of Australia. Bachelor Degree in Psychiatric/Mental Health Nursing or equivalent, or, Bachelor Degree in Nursing plus a Postgraduate qualification in Psychiatric/Mental Health Nursing.
- Social Workers: An approved degree in Social Work and eligibility for membership of the Australian Association of Social Workers.

Specific qualifications, knowledge and experience that are required for the role

- Comply with all legal requirements pertaining to the position including responsibility for maintaining current registration as required by your professional organisation or other applicable Acts.
- Knowledge of mental health and mental illness.
- Demonstrated experience in the mental health assessment, management and provision of therapeutic interventions including couple and group work.

- Commitment to working with consumers from various ethnic backgrounds.
- Capacity to support the development of other team members while working as a member of a multi-disciplinary team.
- Skills in liaison, collaboration and negotiation with other service providers, consumers and carer groups and other community agencies.
- Demonstrated commitment to ongoing professional development.
- Computer literacy is essential.
- Current Driver's License.
